New LLB requirements and exemptions explained:

1. If a student has passed Research Literacy (SCL1502) – don't have to register for Introduction to Research Meth for law and Criminal Justice (IRM 1501).
2. Students who have passed **BOTH** Origins (FLS 1501) and Foundations (FLS1502) – Don't have to register for The History of the Foundations of South African Law (HFL 1501) **AND** Introduction to African Philosophy (PLS 1502).
3. Students who have passed **EITHER** Origins (FLS 1501) OR Foundations (FLS 1502) – **MUST** register for The History of Foundations of South African Law (HFL 1501).
4. Students who have passed **BOTH** Civil Procedure 1 (CIP 2601) and Civil Procedure 2 (CIP 3701) – Don't have to register for The New Civil Procedure Module (CIV 3701) AND Technique in Trial and Litigation (TLI 4801).
5. Students who have passed **EITHER** Civil Procedure 1 (CIP 2601) OR Civil Procedure 2 (CIP 3701) – **MUST** register for the new Civil Procedure Module (CIV 3701).
6. Students who have passed **BOTH** Criminal Procedure 1 (CMP 2601) and Criminal Procedure 2 (CMP 3701) – Don't have to register for the new Criminal Procedure module (CPR 3701) AND Technique in Trial and Litigation(TLI 4801).
7. Students who have passed **EITHER** Criminal Procedure 1 (CMP 2601) OR Criminal Procedure 2 (CMP 3701) – **MUST** register for the new Criminal Procedure Module (CPR 3701).
8. Students who have passed **BOTH** Evidence 1 (EVI 3701) and Evidence 2 (EVI 3702) – Don't have to register for the new Evidence module (LEV 3701) and Techniques in Trial and Litigation(TLI 4801).

9. Students who have passed **EITHER** Evidence 1 (EVI 3701) OR Evidence 2 (EVI 3702) – **MUST** register for the new Evidence Module.
10. Students who have passed Research Meth (HMLLM80) – Don't have to register for the new 3rd year Research Meth Module (LME3701)
11. Students who have passed Research Meth (HMLLB80) **CANNOT AND ARE NOT ALLOWED TO REGISTER for LLB RESEARCH REPORT (RRLB81)** but must choose another elective in its place If they need to meet the required credits.
12. Students who have passed Law of Negotiable Instruments (MRL 4801) – Don't have to register for Company Law (LML 4806)
13. A Student will be required to select **TWO** Electives.
